2. Jurisdiction and Composition of the SAC

The SAC has jurisdiction to hear appeals by students from decisions at the Faculty level regarding a variety of academic issues, provided the appeal process within the Faculty has been exhausted, when there has been either an alleged omission to make a decision on an academic matter, or when there are alleged irregularities or unfairness in the application of academic regulations. The SAC also hears appeals of decisions made by the Senate Discipline Committee, as well as appeals of findings made pursuant to the Hazing Policy.

The SAC is comprised of faculty members, one from each Faculty of the university, and two student members appointed by the Dalhousie Student Union. One faculty member serves as Chair.

3. Caseload from July 1, 2018 to June 30, 2019

There were three notices of appeal received during this reporting period. One appeal was received in Sept 2018 and heard in Nov 2018. Two other appeals were received in March and May 2019. Of these two, one appeal was heard in May 2019 and the other appeal was heard in June 2019, respectively.

Of the three appeals heard by the committee this year, two were academic appeal cases and one was a discipline appeal case. Of the academic appeal cases, one was denied and the other was granted. The discipline appeal case was denied.
